ISO, Management System Certification -Past, Present & Future Contribution for Nation Branding Certification Body.


The history of ISO 9001:2015 Quality Management System is most popular ISO management system in the world; we

can trace its original back to the 1950's with US and UK government who established the standard for military procurement, large corporate organizations which supplied government procurement agencies.

The military standard led by the defense industry to adopt mutual recognition of NATO AQAP, MIL-Q and Def Sten Standards. British Standard BS 5750 was the first specific quality management system standard, 1979 applicable to the industry. (ISO 9001, ISO 9002 and ISO 9003) Standard developed by International Organization for Standardization (ISO) published in the year 1987. These standards have been undergoing review and revision every 5 to 8 years. The history of ISO 9001 with significant changes are given as under:



The current ISO 9001:2015, Quality Management system is widely accepted and recognized in more than 200 countries worldwide.

The independent certification is given to the certification body duly accredited by the accreditation body; more than 100 countries have their National Accreditation Bodies who are governed by IAF: International Accreditation Board. The certificate of compliance issued by the ISO / IAF member countries have been mutually recognized and approved.



In India Quality Council of India was established in early year of 2000 which is an independent Indian



National Accreditation Body. NABCB: National Accreditation Board for Certification Body extend their accreditation of the ISO management system to the certification bodies / conformance assessment bodies. There are number of CAB operating in India providing the certification of various ISO management systems.

The certificate issued by an accredited Conformance Assessment Body is mark of quality; approved and recognized globally.

The ISO certificate provide the assurance of the certified organization that their management system is in compliance with the certified applicable ISO management system ensuring meeting the National, Legal and regulations.

It is very clear from definition that you can issue a certificate to any standard only if the stated requirements are fulfilled by the organisation. System


certification gathered momentum in 90s and during those days getting an ISO Certificate was a very proud achievement. The respect for standard



Edward Deming had introduced 14 points of management. He talks about the management in view of leadership, improvement and many more. Not only Edward Deming but Juran and many other management gurus talked about how quality culture should be there in any organization?

I got introduced with ISO systems in 1992 when it came in India for the first time. Then I eventually was involved in implementation of ISO 9001, QS 9000 and many more. I started my


consultancy post 1997. At that time the word \_ QUALITY, was comparatively new. People had just started talking about quality. Of course, at that time quality was the ownership of only quality control department, nothing else. However, then people eventually came to know that quality is a positive culture and every department is supposed to work on that.

That time, ISO was totally new and we say that it was a kind of a Concept Selling.

I remember that in 1997 and 1998 we used to go to customer for a discussion on ISO , and then the first thing what we supposed to do was, that we need to share what do you mean by ISO, what is the full form of ISO .

It started from there.

In last so many years the culture has been changed and now everybody knows what ISO is. In fact, ISO is having a big glamour nowadays, not only in India but throughout the world.



Earlier it was supposed to be a separate thing, but now, not only quality but there after other concept like environment, health and safety, food safety, medical devices, Information security, automotive standard related quality management system and many more.

They came one by one and they got popularized. Now for this, we say that there was a big cultural transformation. Earlier the organizations were not aware what is quality, they were not aware what ISO is and from there now every organization is talking about quality, and even further more like environment and safety.

Even today they talk about sustainability.

But this journey was not that easy.

There were two important pillars for this.

First one was the consultant and second was the certification body.

Consultant was helping and guiding organization and certification bodies were giving third party certifications and they were very important .

These two pillars were very important for this travel from \_ unawareness of ISO culture to awareness of quality culture.

I think the role of a consultant is vital important over here .

The first thing what the consultant should do is , he should understand the gaps between the organization and the standard requirement. It could be any standard for quality, environment, health and safety, food safety or whatever it could be. So understanding gap needs a good experience and exposure to the world.

We had done ISO for the organization right from just two people to 20,000 people.

We did it for manufacturing as well as service industry. We did in fact to every kind of industry. For that you need to have good knowledge of the processes and activities.

Second, he should have good knowledge of the standard. He should know, in and outs, nuts and bolts of the standard. He should be aware of shall, maintain and retain, and everything of the standard.

Thirdly, he should be able to fill in the gap by effective ways. He should use all tools and techniques, all weapons of management.

It is not that easy because the standard is same. Let it be a small organization or a very big company, where manpower is very big in number.

There may or may not be a very good culture for management system approach. There could be educated people, there could be engineers, there could be senior guys or in contrast, there could be a small company of two or three or five people who are not so educated. But the standard remains same. So important role of consultant is he needs to ensure that the organization let it be highly educated guys or no education guys, too many people nor in adequate people, a company with complex process or simple process. It could be high tech companies or very low profile companies.

He has to ensure that the certification should be done; the implementation should be done in the same way because ISO requirements are same. Let it be small, big, company, educated, none, educated, literate, illiterate.

Even different territory, different language, culture are different for each company. So that's why his role is important to understand the organization, understand the gap. He should have good knowledge and he should be having good skill to impart that knowledge to the people of such variance in the organization. I always say that the consultant's effectiveness or his performance is gauged by the organization where he has consulted.



It has got no meaning whether he is very highly qualified or very

highly experienced or he might be aware of each and everything of the standard, but his performance is dependent on how it is implemented in the organization and how the organization executes at the time of audit.

One more thing, after doing so many things the most important thing his guidance to organization in selecting good reputed right certification body. Now a days we have seen that so many fake certifications are floating, so choosing the right certification body which should be authentic, it should be legal and the certificate should have value. So they should choose the right certification body that's very important.

And that's very important because they had taken pains to implement the system, they should get gains .

So the role of certification body is also important and choosing them as a consultant there is very important.

Thus the organization are changing, eventually, India is transforming to a quality oriented nation.


Our Honorable Prime Minister in 2014 on 15th of August declared the vision of our country - Zero defect Zero effect to get recognized globally.
