ISO journey started after the Second World War in the year 1946 when delegates from 25 countries gathered in London to discuss the future of standardization. ISO was established on 23rd Feb 1947 to have International harmonized standards as key to the world's reconstruction era to build a new world. ISO celebrated seven decade of the services to the international world.

Simultaneously National Standardization activity started after the independence, year 1947 with establishment of ISI: Indian Standards Institution to prepare and promote the

adoption of national standards for products and services.

ISO international standards are adopted and recognized by more than 200 member countries world-wide. ISO is a network of the national standards bodies (NSBs) popularly known as accreditation bodies with one member per country. Among other activities, ISO's central secretariat located in Geneva, Switzerland, coordinates the organization and development of international standards on various field of manufacturers and service sector industries. They are not only developing various management system international standards but the products standards those are harmonized and based on international and national standards with sound engineering, quality, safety and environmental practices.

ISO organization also helps raise public awareness of international standards and standardization. They also work with other international and national organizations such as IEC and ITU to celebrate annual WORLD STANDARDS DAY. ISO also engages the wider public through their consumer committee on standards development (COPOLCO)

Role of Accreditation Bodies: Accreditation bodies are established in many economies with the primary purpose of ensuring that "conformity assessment bodies" are subject to oversight by authoritative body. Accreditation bodies that have been peer evaluated as competent sign regional and international arrangement to demonstrate their competence.



#### QUALITY, QUALITY, QUALITY

There are many certification bodies, operating in India today, considering India's growth & development and world's largest manufacturing hub.

Quality of the certificates being issued by the CB's very much differs in the Quality of their certification services. We can divide into the following four main categories

- a) CB, National Accreditation certificates
- b) CB, International Accreditation Certificate (with their branch office in India)
- c) Sub-contractors, CBs Licenses
- d) Consultants

Unfortunately many of the CB's have been operating in India are from categories C & D i.e. Sub-contractors and consultants. The quality of the ISO certificates issued by these categories is big question mark, as there is poor monitoring and control on these categories of CB's

Otherwise quality of the certification services by categories A & B are very good with compliance to the ISO requirements, independent, value added internal benchmark.

The organization selecting right CB's is very vital and important receiving the value for money and quality ISO – International certificate. Another area of concern the L1 during tendering can adversely affect the quality.
